- The purpose is to promote integration of Disaster Risk Management in Nepalese tourism by enhancing the private sector engagement for promotion of risk sensitive ecotourism.
- To adapt new and innovative technologies in Disaster Risk integrated tourism.
- To motivate private sector to nurture safer and reliable tourism throughout Nepal.
- Duration: 15 months

Project Objective and Approach



- The overall aim of the project is to promote risk sensitive, resilient tourism through engaging public private sector. The approaches that will be adopted in the project are as follows:
 - Rights-Based Approach
 - Community Based Participatory Approach
 - Good Governance
 - Public private partnership
 - Social Accountability and Transparency
 - Inclusions and holistic approach on disaster management and climate resilience.
 - Gender Equity and Social Inclusion

Rationale



- The proposed project targets multiple municipalities to boost its pristine natural beauty, sky-high Himalayas Range, and endless culture and traditions.
- It will improve the community's livelihood, the capacity of the local government, youth empowerment, use of technology, use of local resources for promoting tourism entrepreneurship and employment.
- These municipalities are in the periphery of Kathmandu and rich in historical, cultural, and natural beauties. It brings a high potential for an increase in the number of tourists.
- There will be many indirect benefits to the local community and municipalities with increased tourists and visibility.

Tourism Promotion Committee mobilization



- Dhulikhel municipality has formed Tourism Promotion Committee with an aim to engage private sector and work as a team to enhance safer and risk-free tourism.
- The committee includes representatives of the major private sectors working in the sector of tourism in Dhulikhel municipality.
- Regular sharing and updating about the challenges and opportunities within the committee would help to design program and plans in the Disaster Risk Management integrated tourism.
- SMART project aims to sustain and mobilize TPC and provide technical support if needed.



Implementation of plan and guidelines

- Dhulikhel municipality has developed "Risk Sensitive Eco-tourism Plan" and "Disaster Sensitive Tourism Promotion Fund (Operational guideline)" with the technical support of ECO-Nepal and USAID/Tayar Nepal.
- Implementation of the plan and guideline through participaotry approach.
- SMART through PPP project aims to provide technical support to implement the plan and guideline.

Beneficiaries



- The beneficiaries will be from Chagunarayan- Mandandeupur-Banepa-Dhulikhel- Namobuddha- Panauti Municipalities as hiking trial covers these municipalities.
- External and Internal Tourists who travel to the municipalities and hiking trial.
- Locals of the municipalities. Especially, local business holders along the trial.
- Women, youth, disadvantaged groups and indigenous people living along the trail will be focused on the community level to ensure inclusion.

Issues and Gap identified



Study conducted by ECO and Tayar Nepal(USAID funded project) identified:

- 1. The gaps at the targeted municipalities lack proper planning and programs for promoting and addressing the risk along the trail,
- 2. The gap in defining the roles and responsibilities of the municipalities to promote tourism, information management for the tourists, awareness programs for minimizing the hazards and risks in the trail, technical teams to promote the safety of the tourists and travelers, and availability of the facilities along the trail and active response team.
- 3. Lack good governance on DRR, risk assessment, knowledge and education, risk management and vulnerability reduction, and disaster preparedness and response in any new destination development.
